Mayor, Toni Dever – She spoke with the Tintic Historical Society asked them to submit engineered stamped plans for the old IGA/Union building. She said CentraCom had installed temporary Wi-Fi in the Memorial Building and wanted to know if the Council would like to have it installed permanently. The Council discussed the option. The hot water heater in the Memorial Building was leaking and has now been replaced. Southwick Plumbing will be fixing the issue with the fire hydrant on Beck St and putting in the new fire hydrant on Eagle St. She has a meeting on the 27th in Nephi discussing the floodplain. She asked Council Member Pugh to go with her.

Jeremy Snell – He was excited to announce that the Utah Film Commission chose Eureka as one of the sites for their film trail markers. The marker was delivered and accepted by Patricia and Rachel and installed in front of the Memorial Building by Joe. He thanked Shanna Memmott and Utah Film Commission for choosing Eureka as one of their sites. He gave a run down on the events happening during the celebration. Unfortunately, they had to cancel the fireworks because of the State fire restrictions and the dry conditions.

Scott Pugh – The Planning Commission will be holding a Public Hearing for short term rentals on August 20th. They are also considering allowing ADUs (Accessory Dwelling Units).

They will need to attend a Planning Commission meeting. Council Member Pugh said he will have it put on the Planning Commission agenda for the August 20th meeting. The Council asked some questions about the property. Attorney Christopherson gave an explanation on how the process will work. He said there is more to it than just going to the Planning Commission. There are some State mandated steps that are needed. He will get the list of steps compiled and

will email them to the Mayor, Council, and Recorder Bigler. If a Public Hearing is needed, then it could take longer than the scheduled Planning Commission meeting on the 20th.

Council Member Haynes made a motion to move into Executive Meeting. Council Member Pugh seconded the motion. All in favor meeting moved into Executive Meeting 7:44 pm.
