On Saturday, January 30th, the Tintic High School Cheer Squad traveled to Riverton High School to compete in the Utah High School Cheer State Competition. In order to compete, they had to qualify at the Southern Region Competition at Salem Hills High School on January 16th. Ten THS freshman and juniors make up the cheer squad including Olivia Thornock, Jordan Garbett, Maddison Price, Bailey Robertson, Jentry Robertson, Savannah Peterson, Makayla Fox, Em ma Grimstead, Chelise Tromble, and Selena Nieto. ## BAD WRECK ON SAN PEDRO

The Overland Westbound and Morning Train out of Tintic Crash into One Another Five Miles North of Tintic Junction.

#### DEAD

Dennis Hannifin, a miner who was recently employed at Tooele. Leg broken and internal injuries. Died en route to hospital.



### INJURED

J.W. Leavitt engineer on No. 1. Hip and leg crushed. May Die. Lives at Salt Lake.

F.O. Sullivan fireman also a resident of Salt Lake. Leg fractured in two places. Also badly scalded. Robert Kinder brakeman on No. 200 back injured. Lives at Lehi.

Ben M. Bingman messenger on No.1. Lives at Los Angeles. Internal injuries.

Pat McNinnay of Anaconda Montana, left leg crushed. May die.



Ed Henderson, colored, scalded. Lives at Los Angeles. N.H. Bloom, manager of Leader Store in Eureka, internal injuries not serious.

A.T. Orton of Sandy ankle sprained.

Joseph Price, Salt Lake, Sprained back and internal injuries.

W.J. Maxton, head cut.

Mrs. Eva A. Adams of Dexter NY, badly cut and sprained back

Mr. and Mrs. Fred Merrill of Beaver Utah, bruised and cut but not serious.

Mrs. Chris Keneck, San Diego, Cal. Slight internal injuries.

## **CONTINUED ON NEXT PAGE:**

A very serious wreck occurred on the mainline of the San Pedro R'y about five miles to the north of Tintic Junction at seven o'clock yesterday morning. No. 1, the overland train en route to Los Angeles colliding with No. 200, the new train which was recently put on between Lehi Junction and Tintic points. The head on collision occurred upon a curve which made it impossible for the engineers to see more than a few hundred yards in front of them. The Overland train carried about twelve or fourteen coaches and being behind schedule time was running quite rapidly at the time of the collision. The local which left Eureka at 6:25 in the morning carried but one passenger coach and a baggage car. Despite the fact that the engineers upon both engines did everything possible to slow up the two trains came together with awful force. Both engines were thrown from the rails and badly demolished. The two baggage cars were also badly smashed and a couple of other coaches also left the rails.

As near as can be learned at this time, the blame for the accident rests upon conductor McCarthy of the Overland train who should have stopped his train at Boulder switch to ascertain whether or not the Tintic train had passed from the main line to the old Fairfield line. The Tintic train uses the main line only between Boulder switch and Tintic Junction and had it been on time yesterday morning it would have been off the main line fully ten minutes before the hour of the collision.

Drs. Gose, Lay, Hensel, Laker, and Howell did splendid work on taking care of the injured men. Dr. Hensel was dispatched immediately to the scene of the accident and the other local doctors devoted their time to setting the fractured limbs, sewing up wounds, otherwise giving the injured men relief. The ware room at the San Pedro depot in the city was converted into a temporary hospital and after the injuries had been properly attended to the victims of the accident were placed in a box car and sent to Salt Lake. They were taken as far as the wreck by the local freight crew on the San Pedro R'y and then transferred to a special train which had been sent out from the capitol. The members of the crew on No. 200, the north bound train running between Tintic points and Lehi Junction were Conductor Johm Wood, fireman Charles Edwards, brakeman Robert Kinder, and R.E. Talbottt.

Most of them reside at Lehi and Kinder was the only one injured. The engineer and fireman on No. 200 saved themselves by jumping. Engineer Leavitt and Fireman Sullivan on the through train remained with their engine and was taken from the debris after the big locomotive had turned completely over. Sullivan was badly scalded in addition to his broken bones.

The Sisters of the Holy Cross Assisted in caring for the injured men after they had been brought in the city. Older ladies of the camp also gave the physician valuable assistance.

Dr. W.F. Aughenbaugh of 524 West 134<sup>th</sup> Street New York City who was one of the passengers on the Overland train performed great work in giving first aid to the injured. Through the excitement which followed the collision Dr. Aughenbaugh made his way to the front of the through train where the most serious were put on one of the coaches and brought to the city. When Pat McNinnay was taken from beneath the debris the blood was spurting to a height of about three feet from him bleeding from his leg and Dr. Aughenbaugh made a tourniquet garb from the carcass of a steer to tighten it on it and this maneuver stopped the flow of blood and thus saved the mans life.

Dr. L.B. Laker local physician for the San Pedro R'y Company on behalf of the official of that road desires to extend thanks to the physicians, the Sisters of the Holy Cross, the ladies of Eureka, and others who assisted in caring for the injured men while they were here. Hundreds of people were on hand when the injured men reached the depot in this city and all of them were ready and anxious to render assistance all of which was highly appreciated. Those who furnished hot water bottles, sheets, blankets, pillows, etc. and failed to have the same returned to them are requested to give Dr. Laker a list of these articles at once in order that local people may be reimbursed for whatever loss they have sustained.

Dr. Laker also wishes to thank the Sisters of the Holy Cross and others who accompanied the injured men to the hospital at Salt Lake.

Work was received from the hospital today stating that the injured men are all doing nicely. There has been but one death up to this time.
