Bradley Kenneth Larson, beloved husband, father, and friend passed away at his home on May 17, 2018 after a courageous battle with cancer. Brad was born on September 14, 1954 to Leo Lloyd Larson and Jacquelene (Jones) Larson. He grew up in Vernon and Lofgren, UT. Brad attended high school in Eureka, UT and graduated from Wagner High School, Clark Air Force Base, Philippines in 1973.

Early in life Brad spent a lot of time a horseback back (usually herding sheep or cows) with his late Grandfather and Grandmother (William Bill Jones &

Alta Tone Jones), where he experienced life first hand. He was very fond of the memories he had from his time spent with "Gramps", both good and bad. He had many stories that he enjoyed telling of the good old days he shared with them both.

Brad married his high school sweetheart and best friend, Laray (Dean) Larson, June 22, 1974. They were later joined by daughter Tammy Rae on their 5th wedding anniversary and son Kelly Kenneth near their 9th Christmas together as a family. Brad dedicated his entire life to the love of his family as well as friends.

Brad drove truck and worked construction for a few years after he and Laray married, he then turned to mining. In 1986 Brad and Laray moved to Winnemucca, Nevada where Brad continued his work in mining until 1996. Then he turned to construction and trucking and in 2001 Brad and Laray started their own business where they worked side by side every day.

Brad was a hard worker, loved a challenge, and most of all loved to visit with people. He always seemed to have a positive, upbeat, can do attitude (even at times when it should have been "no way, no how" Brad took pride in finding or making his own way!) He was never too busy or tired to help someone out, family, friend or stranger. In fact, if there were any sort of challenge involved this was even more incentive to lend a hand! Brad had endless stories of different experiences he loved to share.

Brad enjoyed, working, hunting, fishing, telling jokes, camping, singing, playing musical instruments, dancing, and time at the family cabin working and the great outdoors.

Anyone who knew Brad knew his love of Jokes, odds are if you knew Brad he had told you at least one joke. He didn't just tell a joke he often started out by making you believe he was telling you a fact or experience he had, drawing your complete attention until the punch line where one was sometimes left wondering if this was a joke or the truth. His kids came to call these Bradisms, they were so unique. Brad will be greatly missed by his family and his many friends but he will never be forgotten.

Brad is survived by his wife and partner in life Laray, daughter Tammy Rae (Marc) Mclean and son Kelly Kenneth (Schye) Larson; father, Leo Lloyd Larson, Brothers Jimmy Lee Larson and William Elmer Larson, Step Father Carl Edward Fields and many beloved family and friends.

He retired from the U.S. Navy after 20 years, on October 1, 1973, as a Chief Petty Officer. He was a Deputy Sheriff for Juab County while living in Eureka, Utah. His second career was spent as Police Officer at Dugway Proving Grounds, Utah. While in this po-

NOTE FROM THE MAYOR

It seems that a few people unable to follow simple instructions make life more difficult for the many. The City Council debated the pros and cons of the spring cleanup including the cost of supplying roll-offs at a convenient location. It was decided to give it one more try to see if we could make it work. Well, it failed. Apparently there are people in town who still can't read or they think that rules apply to everyone else, but not to them. There was a clearly marked roll-off for metal. The city can offset some of the cost of providing this service by selling some scrap metal. The first metal bin was about half full when someone dumped a couple of couches and other garbage on top. We had to pay to have it sent to the land fill. The second bin was nearly full when someone dumped and old TV in the bin. We were able to get it out so we made a few dollars off that bin, but why do we need to climb into a bin to take out a TV that is clearly in the wrong bin? All of the bins that went to the land fill had yard waste in them. The city pays \$250.00 per ton in addition to the cost of the roll-off. Yard waste should only be put in the yard waste burn pile at the dump. Access to the dump was 24 hours a day so there is no reason, other than lazy, that the yard waste was put in the roll-offs. When a roll-off was full people just threw their garbage on the ground in the area. Is it really that hard to drive the 2 miles to the dump where there was always a roll-off with plenty of room?

Because of the actions of the few, the rest of the town will suffer as this will be the last year the city will provide this service unless someone can come up with a workable solution.
