# COMMUNITY VISION

The most important part of the Eureka general planning process is the development of a Community Vision Statement along with further clarifying goals and strategies. The Community Vision Statement reflects the interests and concerns of the citizens, establishes the direction Eureka will take, and provides a framework for specific accommodations to guide the future of the City. The Community Vision Statement was derived from the existing Vision Statement found in the 1996 General Plan and input from the current Executive Committee. The specific comments and discussions of the Executive Committee may be found in Appendix A of this plan.

#### 2.1 Introduction

For a community to be successful, it must have a strong sense of vision, understand its strengths and weaknesses, and determine where it is today and where it wants to be in the



future. A Community Vision Statement creates a guiding principle for community. leaders to follow. When a decision needs to be made, that Vision Statement can guide community leaders in determining if their solution better enhances the place its residents want it to be. If the plan is followed, the community eventually becomes a reflection of its vision. If the plan is not followed, the community will veer away from the desired community reflected in the Vision Statement. The General Plan and the Community Vision

Eureka has a strong sense of community vision. In the Community Survey gathered specifically for the General Plan, many questions collectively contributed to provide an overarching image of how the members of the community view their City. The vision that emerged indicates the residents of Eureka love their small, tight-knit community and historical heritage. The respondents largely agree that adopting a pro-growth sentiment would have a positive impact on their community (89% of respondents) and possibly contribute to historic preservation efforts.

During the Executive Committee meeting, committee members were asked to think about Eureka as a whole, the City's past heritage, its current state of being, and the future of the City as they saw it in the context of its past. With that vision in mind, the committee members jointly discussed each clause of the 1996 Plan created to guide future City government and planning decisions. They were asked to decide if those strategies were still expressive of their vision for the future of Eureka. The general consensus, with major adjustments, was that the Vision and Strategies adequately represent their hopes for the City.
