ADMINISTRATIVE FEES

Copies

- 1) Black Copies..... \$.25 per page
- 2) Color Copies..... \$.50 per page
- 3) Picture Copies..... \$ 1.00 per page

Fax Transmissions

- 1) Incoming..... \$.25 per page
- 2) Outgoing..... \$ 1.00 per page

GRAMA Requests

- 1) Request must be in writing, using GRAMA Request Form
- 2) Once request is received, the Town Office has ten (10) days to fill the request
- 3) First 15 minutes of research time..... No Charge
- 4) After initial 15 minutes..... \$ 12.50 per hour
- 5) Applicant will pay for all additional expenses associated with the government records request, including research, supplies to grant the request, travel expenses, professional fees etc.

Notary Service

- 1) Resident/Non-Resident..... \$ 5.00 per signature

Return Check Fee

- 1) Any returned check..... \$ 25.00 per item
- 2) Certified Mail to notify of delinquent account..... \$ 10.00

CIVIL PENALTIES (For Violation Of Ordinances)

Abatement Costs

- 1) Removal of noxious weeds; garbage, refuse, deleterious objects or structures, including staff time..... \$50.00 per hour

Penalties (Civil Penalties assessed for multiple offenses for previously cited violations within a twelve (12) month period shall be in addition to the civil penalties assessed on the prior citations for the same offense.)

- 1) First Offense..... \$ 100.00
- 2) Second Offense..... \$ 250.00
- 3) Third Or More Offense-Same within twelve months..... \$ 500.00

PARKS, RECREATION, TRAILS and OPEN SPACE

Impact Fee \$1,303.25

Memorial Building

- 1) Cleaning Deposit..... \$ 50.00
- 2) Rental Fee - All Day \$ 125.00
- 3) Cost doubles if both floors are used. Non-Profit organizations may meet in the building up to twice a month without paying and must be scheduled through the City Office. Should they meet there more than twice, cost is as stated above.

Parks & Recreation

- 1) Pavilion (includes restrooms only)..... \$50.00 Deposit + \$50.00 Per Day
- 2) Snack Shack\$50.00 Deposit + \$50.00 Per Day
- 3) Propane Grill (Does not include Propane)..... \$50.00 Deposit + \$50.00 Per Day

CEMETERY

- 1) Resident per space..... \$200.00
- 2) Non-Resident..... \$450.00

 - a. Weekdays \$250.00

LICENSES AND PERMITS

Animal Licenses

As per Eureka City Ordinance No. 980 an Ordinance regulating licensing and control of dogs and other animals within Eureka City Section 13-242 License and Registration Required: It is unlawful for any person to keep, harbor or maintain any dog six or more months old unless such dog has been registered and licensed with Eureka City. Anyone owning, keeping harboring, maintaining three or more dogs over the age of six months shall be considered operating a dog kennel and shall be required to pay an annual kennel license fee of \$25.00 per year upon approval by City Council

1) Neutered/ Spayed.....	\$10.00
2) Female.....	\$25.00
3) Male.....	\$25.00
4) Kennel License, for 3 or more dogs.....	\$25.00 plus each dog license
5) Commercial Kennel License.....	\$50.00 plus Business License Fee
6) Late Fee.....	\$5.00 per month/per dog

Building permits are required for new structures (homes, manufactured homes, storage sheds, remodeling/refurbishing, electrical, plumbing, porches, decks, etc.) Call the City Office to pick up a building permit application package.

- 4) Soil Purchase.....Based on current costs from supplier.

Encroachment Permit

- 1) Application Fee..... \$ 25.00
- 2) Completion Guarantee Deposit
 - Pavement Surface (including chip/seal) \$3,000 up to 70 sq. ft.
 - Pavement Surface (including chip/seal)..... \$45.00 per sq. ft. over 70 sq. ft.
 - Gravel Surface..... \$ 6.00 per sq. ft.
 - Unimproved Surface..... \$ 3.00 per sq. ft.

Larger loads will be charged accordingly. **Construction waste is not allowed.** Those who are building new homes, garages, remodeling, etc. will be required to get their own dumpsters.
