## **DISCUSSION ITEMS**

a. Charles Davis and Bryan Kessinger – Department of Workforce Services, EDA Grant Bryan has been helping him look at different avenues to get his business up and running. During this process he has found out about opportunities for the City. Bryan has found some serious money (CARES Act) to put into City's infrastructure and opportunities it would create. If Eureka is interested, it is going to take a lot of teamwork. Six County will be discussing this at their meetings. Every county/city is competing for this money. Bryan explained how this grant would work. Every proposal needs to include an incredibly detailed plan put on paper.
